On Saturday, December 24th, 2022, myself and Deputy Ady responded to 16 Rear Mechanic Street in reference to a death investigation.

Upon arrival, I made contact with Shiloh EMS who advised that they found the victim, Terrence Hamman, dead on arrival, laying in his bed. Shiloh EMS advised that Terrence's sons, William and Steve Hamman (involved others), felt that there may be foul play involved.

I then made contact with William and Steve who advised that they had come to check on their father because he was not answering his phone. William advised that when he arrived at the house, his dad's truck was gone. Steve advised that he then called their other brother, Robert Hamman (offender), who advised that he and Terrence were stopped at a gas station and heading toward Lorain. William advised the story was not adding up so he made entry into the house where he found Terrence dead in his bed.

William advised that Robert had been staying with their dad and that the two of them had been in a dispute the evening prior. William advised that Robert had taken their dad's truck, crashed it into a ditch, and then fled from the tow truck driver; the truck was towed back to Terrence's house. William advised that Terrence told Robert to get out of his house. William advised that he called to check on Terrence later that night but that he did not answer.

I made entry into the Western door of the house which led into the kitchen area. There was a mop and bucket with water in it near the doorway, the water appeared to have a red tint to it. The kitchen floors were a hard surface. The basement door was on the Eastern wall of the kitchen and had what appeared to be smeared blood on it. There also appeared to be blood on the floor in front of the basement door. To the left of the kitchen was a doorway, it led to Terrence's bedroom. The bedroom had light colored carpet with what appeared to be several blood stains. There were also several towels placed on the bedroom carpet that appeared to have blood stains on them as well.

Terrence's body was observed laying in his bed with his head near the headboard and his feet near the footboard and he was covered by a blanket. Terrence's head was partially exposed, facing the Western bedroom wall. I observed dried blood running from Terrence's ears, nose, and mouth. There was also dried blood on Terrence's hand. William advised deputies that he partially lifted the blanket when he went to check

There was a bathroom attached to the Northern wall of Terrence's bedroom. There was another doorway off the Southern wall of Terrence's bedroom that led into another room, it contained two safes and some covered furniture.

While on scene, Terrence's ex-wife and her husband arrived at the residence, but did not enter the house. Due to the circumstances of this death, William and Steve were asked to wait in their vehicles. Photos were taken of the crime scene and will be submitted as evidence. The scene was secured while we waited for the arrival of the Coroner Investigator at which time I started a crime scene log.
