On the date and time of this report I was dispatched about a missing person. I followed up at 109 E 9th St where I spoke to the caller, Angela Staley, and her two other daughters, Amberlee and Mikhaela Staley. Angela reported her daughter Shealeah Staley may be missing.

While at 109 E 9th St Angela stated the last time anyone had seen Shealeah was August 31st 2023, and the last thing she said was she is going to kill herself. Angela advised Shealeah is bi-polar and not medicated, and had made suicidal comments before with no means to follow through. Angela advised Shealeah has a pre-paid phone number that does not work. Neither Angela, nor Amberlee, and Mikhaela know any of her friends or where she would go. Angela did state she had contacted Mansfield PD to see if they had recent contact with Shealeah, which they did not. I had dispatch confirm this with Mansfield PD, and they stated they had no recent involvements with Shealeah and she is not in their jail.

At the beginning of September Angela reported her vehicle missing. Shealeah ended up taking the vehicle to Mansfield. Shealeah was contacted and the vehicle was returned to Angela, reference report number (23-67568).
