He mentioned that he had taken a beer from the fridge to enjoy as an adult beverage at the kitchen island. Heidi then retrieved some liquor and placed it in front of Nicholas, telling him to "drink his problems away," as he often does. This triggered Nicholas's anger, and he threw the beer can he had just opened at Heidi.

I asked Nicholas if anything else had happened before my arrival, and he confirmed that was all. I then spoke with Heidi, who provided a similar account of events but did not mention the liquor bottles being placed in front of Nicholas.
